MEMORANDUM OF UNDERSTANDING between

THE EUROPA-KOLLEG HAMBURG (GERMANY)

and

GEORGIAN UNIVERSITIES (GEORGIA)

The Europa-Kolleg Hamburg and Georgian Universities,

Being inspired by the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and Georgia, of the other part,

Recalling especially articles 358 and 359 of the Association Agreement on cooperation especially in the field of higher education,

Aiming to promote a high quality of European Law and European Studies teaching in higher education, to foster international academic cooperation in this field, to deepen understanding and knowledge on the European integration process, and to conduct academic dialogue on the European Union (EU) and EU-Georgia relations, agree to explore:

- a. co-operation on academic programmes;
- b. development of joint research activities;
- c. training and development possibilities for doctoral students;
- d. student exchange and/or visiting programmes;
- e. exchange of information, including the results of teaching and research collaboration;
- f. any other activities viewed to be mutually beneficial.

The terms of co-operation for each specific activity implemented under this Memorandum of Understanding (MoU) shall be discussed and mutually agreed upon in writing by all parties prior to the initiation of that activity and will be the subject of separate agreements.

This MoU becomes effective from the day the representatives of all institutions affix their signatures below and will continue for an initial period of three years, whereupon it shall be reviewed and may be extended by mutual written agreement of all institutions. This MoU may be revised through mutual agreement of all institutions and may be terminated by either party upon six months' written notice signed by the presiding
