**The Procedure for Providing Students of the Relevant Program with Further Education
in Case of Changing or Cancellation Educational Programs
(Second Edition)**

In order to improve the quality of education, refine the program, offer better services to the community, as well as ensure mobility from one educational program to another, the university may change or cancel an educational program, and a student may decide to change the educational program.

In the event of a change or cancellation of an educational program, it is important for the university to provide students of the relevant program with further education.

1. In the case of modification of the educational program implemented at Tbilisi Humanitarian University (Changes and/or additions to the educational program, changes or removal of credits in individual academic disciplines, and other cases) the changes will not apply to students of educational programs who have already earned the appropriate credits in the modification part of the educational program.
2. Within the framework of Tbilisi Humanitarian University, the student's right to change the educational program is ensured by the relevant (receiving) faculty of Tbilisi University in accordance with the conditions for the conformity, compatibility and recognition of education (credits) obtained during the study period established by the "Rules for obtaining, suspending, terminating, mobility, and recognizing the status of a Tbilisi University student", in accordance with the rules established by the current legislation of Georgia.
3. In the case of cancellation of the educational program implemented at Tbilisi Humanitarian University, before setting up a petition, the faculty council, in order to protect the interests of students and ensure their further education, is obliged to study

the possibility of merging the educational program to be canceled with an adjacent educational program or replacing it with a new educational program and submit this information to the Academic Council along with a petition.

4. In the case of cancellation of the educational program implemented at Tbilisi Humanitarian University operates in accordance with and is obligated to the current legislation of Georgia:
 - 4.1. Offer the student an educational program corresponding to ECTS (European Credit Transfer and Accumulation System) credits;
 - 4.2. Offer the student an educational program corresponding to ECTS (European Credit Transfer and Accumulation System) credits;
 - 4.3. Provide students with information about authorized higher educational institutions in Georgia and the relevant accredited educational programs they offer;
 - 4.4. In the case of cancellation or changing of the educational program implemented at Tbilisi Humanitarian University in order to ensure further education of students, Tbilisi Humanitarian University signs memorandums of understanding and agreements with higher educational institutions offering authorized/accredited educational programs of similar level and content;
 - 4.5. The university is obliged to inform the student about the rules, terms and conditions of mobility.
5. In the case of cancellation of the educational program implemented at Tbilisi Humanitarian University operates in accordance with and is obligated to the current legislation of Georgia and The University is authorized to provide students with information about universities abroad and the relevant educational programs they offer;
6. In the case of cancellation of the educational program implemented at Tbilisi Humanitarian University, Students of this program will have their student status suspended until mobility is provided, but not for more than 5 years.
